



Accepting Nominations!

The mission of the Governor's Volunteer Service Awards is to promote an ethic of service and volunteerism and to recognize volunteer efforts that strengthen communities and improve quality of life for Arizonans.

A panel of judges from across the state will select the award recipients. Nominations will be accepted through January 15, 2010 and the winners will be announced as early as February 2010. The Governor and Governor's Commission on Service and Volunteerism will host a reception to honor the 9th Annual award recipients in the spring of 2010.

Awards may be given in these categories:

Lifetime

Achievement: Individuals who exemplify the ideals of service for the past 25 years or more.

National Service: Current or alumni, individual member of AmeriCorps*State, National, Tribal, AmeriCorps*VISTA, Senior Corps program, or Service-Learning Practitioner (adult advisor).

Service Learning Project: A course-based, credit-bearing educational experience in which students participate in an organized service project that meets an identified community need; includes a reflection on the service activity in such a way as to gain further understanding of course content, a broader appreciation of the discipline, and an enhanced sense of civic responsibility (Bringle & Hatcher, 1995).

Youth: Individuals 17 years of age or younger at the time of nomination.

Youth Group: Groups of two or more youth, 17 years of age and younger at the time of nomination. Please describe individual roles and leadership of youth act(s) of service in nomination. Category includes youth clubs, faith youth groups, afterschool programs, scout troops, etc.

Outstanding Mentor: Adult or youth mentor, mentoring for a minimum of three years in a formal mentoring program (e.g., Big Brothers Big Sisters, Phoenix Youth at Risk, Arizona Quest for Kids), a compelling mentoring story.

Adult: Individuals 18 years of age or older at time of nomination.

Adult Group: Groups of two or more adults, 18 years of age and older at the time of nomination. The majority of the group volunteers (75% or more) must not be employees of the organization they serve.

Small Business/ Government Agency: Entities with 100 or fewer employees. The award will be given to an entity whose employees volunteer on behalf of the business/government entity.

Large Business/ Government Agency: Entities with 101 or more employees. The award will be given to an entity whose employees volunteer on behalf of the business/government entity.

Nonprofit/ Faith Based: Organizations that are registered as a 501(c)3 or 501(c)6 nonprofit entity with the Internal Revenue Service.

How to Nominate: Complete application form and no more than 2-page response to essay questions.

Responses may not exceed **200 words per answer** (total essay not to exceed 1000 words). Additional materials will not be considered. Essay portion may be typed, hand written, or completed online.

1. Overview: Brief summary regarding the volunteer service performed by the nominee.
2. Need: Describe how the service performed by the nominee addressed a specific need in the community.
3. Action: Describe how the nominee was actively involved and took initiative.
4. Innovation: Describe how the nominee used creative methods to solve community problems.
5. Impact: Describe how the nominee's service produced positive changes and provided an example for others.
6. Please complete essay with a brief summary statement.

Governor's Volunteer Service Awards Guidelines

Guidelines:

- Volunteers may be nominated by anyone or may nominate themselves.
- Volunteer service must be performed in Arizona and may not include hours served as part of academic credit.
- Nominee's volunteer organization must serve the community at large (not limited to its own members).
- Nomination essay must not exceed 1000 words (two pages).
- In the event that a nominee is submitted multiple times, the review panel will consider only the first nomination form submitted.
- The Commission reserves the right to award one or more honorees and reserves the right to withhold distribution of an award if the Commission deems it appropriate.
- Any youth, adult, group or business compensated by salary or any other means from the organization that benefit from their services is not eligible to receive an award.
- A member of national service programs in Arizona (e.g. AmeriCorps, AmeriCorps*VISTA, AmeriCorps National Director or Senior Corps) is eligible only in the National Service category.
- Previous winners are not eligible for nomination.
- Staff and Governor's Commission on Service and Volunteerism members are not eligible.
- Entries are received in confidence and become the property of the Governor's Commission on Service and Volunteerism and will not be returned.

Judging Criteria:

- Need: Service addressed a specific need in the community.
- Action: The nominee was actively involved and took initiative.
- Innovation: The nominee used creative methods to solve community problems.
- Impact: The activity or service produced positive changes and provided an example to others.
